







MEANING AND ELEMENTS OF ADVOCACY






ELEMENTS OF ADJOCACY

- 3. Persuasion Skills A lawyer must convincingly present arguments using logic, law, and precedents.






6. Analytical Ability – Lawyers must analyze facts and laws to craft strong legal arguments.

7. Client Representation – Understanding and effectively representing the client's interests within legal boundaries.




Sir Edward Abbott Parry, a British judge, introduced the concept of the Seven Lamps of Advocacy, which are the guiding principles of an ideal advocate:

- 1. Honesty An advocate must always be truthful to the court, client, and colleagues.
- 2. Courage Advocates must fearlessly represent their clients, even in challenging circumstances.
- 3. Industry (Diligence) Hard work and dedication are key to thorough case preparation.



- 4. Wit A sharp mind helps in tackling unexpected situations in the courtroom.
- 5. Eloquence Clear and effective communication is essential for persuasive advocacy.
- 6. Judgment An advocate must possess sound judgment to analyze legal issues and make strategic decisions.
- 7. Fellowship Advocates should maintain good relations with the bench, bar, and society while upholding ethical conduct.



EQUIPMENTS OF AN ADVOCATE

To be an efficient legal professional, an advocate must possess certain essential "equipments," which include:

- 1. Legal Education and Training Formal education in law and continuous learning through case laws and legal updates.
- 2. Good Communication Skills The ability to express legal arguments clearly and persuasively.

3. Integrity and Ethics – Honesty and adherence to professional ethics are fundamental to

the profession.

- 4. Drafting and Research Skills Advocates must draft legal documents precisely and conduct thorough legal research.
- 5. Confidence and Logical Thinking Quick decision-making and logical argumentation are crucial in the courtroom.
- 6. Knowledge of Court Procedures Understanding procedural laws and courtroom decorum is necessary for effective litigation.
- 7. Client-Handling Skills Advocates should be able to counsel clients professionally and maintain confidentiality.

Accountancy for Lawyers




Key Aspects of Accountancy for Lawyers:
